**Death of Mr. H. L. Dalby.** — We regret to announce the death of Mr. Harry Letts Dalby aged 54, proprietor of the leather and boot business in St. James's-square which occurred on Thursday evening at his residence Sisford, Medina-avenue. Mr. Dalby had been in failing health for the last eight years, but he bore his gradually developing affliction with much fortitude and pluckily persisted in coming into the town to his business until within a few days of his death. Sincere sympathy is felt with his widow (formerly Miss Hawkins), and with their only daughter (Miss Audrey Dalby) in their heavy bereavement. Mr. Dalby was a native of Kettering, Northampton. He came to Newport before the war as an employee of the late Mrs. George in the leather business in St. Thomas's-square, and 22 years ago commenced business on his own account in St. James's-square, later opening the boot maker's business at the premises formerly occupied by the *County Press*. Almost throughout his residence here he had been a member of the Conservative Club and had served on the committee, and he was a skilful bowler, a member of the old Conservative Club team and later of the Newport Club. The funeral takes place tomorrow (Sunday); service at St. John's Church at 3 p.m.
