Sudden Death of Mr. T. C. Letcher.- The death occurred suddenly at his home on Thursday of Mr. Thomas Cecil Letcher, of The Vineries, Worsley Road. Mr. Letcher, who was 62 and a retired naval architect, had been suffering from gastric influenza. When his wife returned home from shopping at about 5 p.m. she found him dead. The facts have been reported to the Coroner. A freeman of the City of London, Mr. Letcher was formerly in business as a designer and boatbuilder. He was a Freemason, a member of the Cowes Conservative Club, and the hon. musical director of the Cowes Amateur Operatic and Dramatic Society. He was also the organist at the Mill Hill Methodist Church for a number of years. The funeral will take place at Carisbrooke Cemetery on Tuesday, following a service at the Mil Hill Methodist Church, Cowes, at 2.30 p.m.
