#### PROMINENT BUSINESSMAN

### DEATH OF MR. NORMAN G. SHEARS, J.P.

Mr. Norman George Shears, J.P., of Littledown, Nodgham Lane, Carisbrooke, a prominent figure in the Island's business, professional and public life, died at his home on Wednesday, aged 55. He had been in failing health for some time.

A native of Bournemouth, Mr. Shears came to the Island during the 1939-45 war as a surveyor for the War Department. After the war he went into practice as a quantity surveyor in premises at Lower St. James's Street, Newport. He was joined in partnership in 1949 by Mr. F. J. Wools, of Ryde, and together they operated the well-known firm of quantity surveyors from premises at 26a St. James's Street. Mr. Shears retired from practice three years ago when he purchased the civil engineering firm of Wall Brothers, of which he was chairman until his death.

Since coming to the Island Mr. Shears gave many years of valued public service. He was elected to the County Council in 1954 as Conservative member for the Fairlee division of Newport. He was appointed chairman of the County Roads Committee in 1955, a position he held until his retirement from the council in 1961. He also served on the County Planning Finance, Staff, Civil Defence, Standing Joint, Children's, Parliamentary and Transport, and Selection committees.

In January, 1957, he took his oaths as a Justice of the Peace for the Petty Sessional Division of Newport, and last sat on the Bench in November. A member of the Rotary Club, he became president in 1959-60. In 1958 he was chairman and organiser of one of the club's most successful ventures in recent years – a careers exhibition for Island youth.

A past chairman of the Newport branch of the I.W. Conservative Association, he was former president of the Newport section of Young Conservatives. He was also a vice-president of the Association, one of its three trustees, and a member of the Executive and Finance and General Purposes committees.

A member of the Albany Lodge of Freemasons, Mr. Shears was also a member of the County Club, Newport Business and Professional Association, the Isle of Wight Chamber of Commerce, and was joint hon. secretary of the Folly Regatta Committee, in which he took a lively interest.

Mr. Shears leaves a widow and one sister. The funeral service will take place today at St Mary's Church, Carisbrooke, at 12.30 p.m.

Baldwin on behalf of Chief Superintendent P. W. Paddon and Island police officers. Both expressed sympathy with the family.
