The Late Mr. G. M. Stewart.- The death took place suddenly on Tuesday as the result of a heart attack shortly after his removal to St. Mary's Hospital of Mr. George Malcolm Stewart, aged 62, of 12 Shide Road, who was well known and much esteemed in local business circles as chief clerk in the transport department of Messrs. Gubbins and Ball. He was at work on Friday week and his sudden death came as a shock to his many friends, who deeply sympathise with his wife and daughter in their unexpected bereavement. Mr. Stewart came to the Island from Brighton in 1925 as book-keeper in the employ of the Channel Fuel Company. He and his wife became popular members of the Victoria Sports Club, Mr. Stewart being a keen tennis player and cricketer. In 1931 his activities in this direction were unfortunately ended by a motor-cycling accident, in which he sustained a badly fractured leg, which left him crippled, but he triumphed over this handicap with great pluck and resumed his work with the Channel Fuel Company at their local office and with that company's successors. He had been chief clerk to Messrs. Gubbins and Ball for some years. The funeral service takes place to-day at St. John's Church at 2 p.m.
