DEATH OF MR. CHARLES E. LOCK, T.C.

It is our painful duty to record the death of Mr. Charles Edwards Lock, which took place, from typhoid, at his residence, Lynwood, St. John's-road, Newport, on Wednesday night. The deceased had been for some five years a member of the Corporation of Newport, and his death in the very prime of manhood in a distinct loss to that body and the community at large. In the performance of his municipal duties he exhibited an independence, a straightforwardness, and a conscientiousness which won for him the sincere respect of all parties, and the "vacant chair" will be sadly contemplated by his colleagues at the Council-board. In private life the deceased was held in the warmest regard, due to his invariable affability and kindliness, and the removal of his genial presence from their midst is deeply mourned by a wide circle of attached friends. The late Mr. Charles Lock was the only surviving son of the esteemed townsman, Mr. Alderman John Lock, J.P., and with him, as well as with the widow of the decreased and every member of the bereaved family, the profoundest sympathy is felt. Before his connection with the Town Council, and while residing at Idlecombe Farm, the deceased was for some years a useful member of the Carisbrooke School Board. He was also a Past Master of the Albany Lodge of Freemasons, a member of the Earl Yarborough Lodge of Oddfellows, vice-president of the Carisbrooke Bowling Club, and connected with most of the social institutions of the town. The funeral will take place at Carisbrooke Cemetery this (Saturday) morning at 11.15. The Town Council and representatives of other bodies have expressed a desire to attend, and it has been arranged that they and other friends shall join the funeral procession at the Cemetery Lodge gate at the time named.

FUNERAL OF MR. COUNCILLOR C. E. LOCK, OF NEWPORT.

The funeral of Mr. Councillor Charles Edwards Lock, whose lamented death on the previous Wednesday was recorded in our last issue, took place at Carisbrooke Cemetery on Saturday morning last, and was attended by the Mayor and Corporation of Newport, the Albany Lodge of Freemasons, of which the deceased was a past master, representatives of the Earl Yarborough Lodge of Oddfellows and other bodies with which he was connected, and a large number of persona; friends, whose presence testified to the high regard in which the deceased was held and the deep regret felt at his premature departure. The ceremony was impressively conducted by the Vicar of Carisbrooke (the Rev. A. W. Milroy). The funeral cortege left the deceased's residence, Lynwood, shortly after 11 o'clock, the coffin, on the brass plate of which was the inscription, "Charles Edwards Lock, died Nov. 14, 1884, aged 43,"

being borne on an open car, covered with beautiful floral tributes. The chief mourners were Ald. Lock (father), Messrs. Seymour Pittis (son-in-law), C.A. Good and S. and F. Pearce, borough treasurer; and several members of the Volunteer Fire Brigade, in uniform, under Engineer Hayles, the Earl Yarborough Lodge of Oddfellows were represented by Bros. C.
