### DEATH OF MR. C. A. GOOD, M.R.C.V.S., OF NEWPORT.

Newport has lost one of its oldest and most esteemed residents and the Island agricultural community a friend who had won the regard and confidence of all by well over half a century's work among them as a veterinary surgeon, by the death at his residence 35a Upper St. James's-street, Newport, on Wednesday, of Mr. Charles Arthur Good, M.R.C.V.S., at the age of 88.

Mr. Good came from Lymington to Newport and commenced practice in 1879 and he continued it with full activity until a few years ago, when he had a serious operation. His strong constitution and fine physique enabled him to make a wonderful recovery, and he had been remarkably active for his age to the last. He passed away very suddenly when about to retire for the night on Wednesday.

For half a century he had an extensive practice, and when Queen Victoria was in residence at Osborne he was entrusted with the veterinary attention to all Her Majesty's horses and farm stock. He also acted as market inspector to the Newport Corporation for many years.

Mr. Good was a sideman at Newport Parish Church for the greater part of his long period of residence at the Island capital. In all his activities his charming courtesy and helpfulness won him high regard. In 1881 he married a daughter of the late Ald. John Lock, who was Mayor of Newport in 1890 and 1891, and sincere sympathy is felt with Mrs. Good in the parting after 58 years of happy married life, and with the family of five daughters and two sons.

The funeral takes place today (Saturday); service at Newport Parish Church at noon.

### THE LATE MR. C. A. GOOD OF NEWPORT.

The large attendance at Newport Parish Church on Saturday at the funeral of Mr. C. A. Good, M.R.C.V.S., the well known Island veterinary surgeon, whose death at the age of 88 we regretfully recorded last week, testified to the esteem in which the deceased gentleman was held.

The service was conducted by the Vicar of Newport (the Rev. W. M. B. Hogg), assisted by the Rev. E. M. Ellis (curate). Mr. A. H. Griffiths, A.R.C.M., at the organ, accompanied the singing of the hymns "For all the Saints" and "Abide with me" and played Bach's "Jesu, joy of man's desiring" as the cortege left the church.

The Vicar said that he felt it was great privilege to have known Charles Good. The first time he met him he at once realised that he was a servant of God. They were gathered together that day to say good-bye, not with feelings of sorrow or regret, but with the confidence that he was at last with the God he had so long and so faithfully served. Whenever he (the Vicar) entered the pulpit to preach, he had always looked for Mr. Good's familiar figure, and seldom did he fail to see him. Their loving sympathy went out to his relatives.
