Death of a Former "County Press" Employee.- The death occurred on Wednesday at the County Hospital of Mr. George Jolliffe, aged 67, of 11 Albert Street, who for 54 years, until his retirement in September last, had rendered exemplary service to the I.W. County Press Co. in the successive capacities of compositor, machinist, and warehouseman. A life-long member of the P.S.A. Brotherhood and an earnest worshipper and supporter of all activities in connection with the Congregational Church, he was much respected in the town. His death followed an operation. Sincere sympathy is felt with Mrs. Jolliffe, who is an invalid, and with the family of two sons and three daughters. Allen (editorial department), E. Melhuish, P. C. Morgan, R. H. Allen, R. Hannam, and B. P. R. Smith (news composing department), P. Appel (jobbing department, also representing the I.W. Branch of the Typographical Association), and R. T. Lawn, sen. (machine department). Mr. Jolliffe was a well known member of the Newport Court of Foresters, in which he had held most of the offices, and the Order was represented by Mr. J. Clarke (district secretary). Others present included Messrs. H. Hollis and F. W. Munt (members of the Newport Brotherhood).
