DEATH OF MR. JOHN SHEATH. - A well-known and highly esteemed tradesman passed away early on Tuesday morning, in the person of Mr. John Sheath, corn and meal merchant, of Nodehill. The funeral takes place to-morrow (Sunday), the service at the United Methodist Church being at 3.0, and a memorial service will take place at 6.30.

JOHN SHEATH.— The funeral of the late Mr John Sheath, corn and meal merchant, of Upper St. James's-street, took place on Sunday afternoon amidst striking evidence of general respect and esteem which the deceased had gained. The service at the United Methodist Church, of which place of worship the deceased had for a great many years been a devoted Worshipper and general helper, was largely attended, the building being full. Mr, W. G. Bartlett (organist) and the choir were in attendance. The hymns "Asleep in Jesus" and "Now the labourer's task is o'er" were sung, and the organist played "O rest in the Lord" at the commencement and the "Dead march" from Saul as the coffin was borne from the church, The Rev. David Watkins officiated, and in an eloquent tribute to the deceased referred in touching words to his true Christian life, his generosity, his kindness of heart, and last but not least, his straightforward, manly conduct throughout is business life. He also expressed profound sympathy with his widow and daughters in their heavy bereavement. The chief mourners were the widow, Mesdames Puddick and Guttridge and the Misses Annie, Nellie, Kate, and Lizzie Sheath (daughters), Messrs. James and George Sheath (brothers), Mr. James Sheath (brother-inlaw), Mrs. Taylor (sister-in-law), Mr. R. Gutteridge, (son-in-law), Messrs. S., C., and T. Sheath (nephews), Mr. and Mrs. C. J. Godfrey, Mr. Leslie Nobbs, and Messrs. I. W. Pitman, and W. H. Croucher (executors). Among the large following were the deceased's employees (Messrs. F. New, W. Starks, W. Earney, and O.
