DEATH OF MR. W. T. WAY BUCKELL

It is our painful duty to record the death of Mr. W. T. Way Buckell, an esteemed member of an old and honoured Island family. Although he had for many years resided at Ventnor, he maintained a close connection with his native town, Newport, and his death has caused the deepest sorrow there, as in all parts of the Island, where he was well known. The sympathy of the whole community is with his venerable mother, his widow and three children, and the other members of the bereaved family.

Our Ventnor Correspondent writes:--A painful sensation was created at Ventnor on Tuesday when it became known that Mr. W.T. Way Buckell had passed away at his residence, 1, Alexandra-gardens. Two or three years ago Mr. Buckell had influenza, which evidently undermined his health, for since then he has had one or two serious illnesses. On the Thursday before his death he was at business, but next day he had an attack of bronchitis, which he could not throw off. Pneumonia supervened, affecting both lungs, and it became apparent to his medical man, Dr. Bassano that his patient's chance of recovery was small. Dr. Bassano was unremitting in his attention to the sufferer, but without avail, and on Tuesday, at about 12.30, two days after his 51st birthday, Mr. Buckell passed away.

Mr. Way Buckell's association with Ventnor dates back many years. His parents, when he was quite a young man, used to be very fond of Ventnor, and the whole family were frequent visitors here, always putting up at Wellington House in Belgrave-road. The deceased was admitted a solicitor in 1874 and practised with his father at Newport and Ventnor, for the firm had by this time extended their sphere of work to the Undercliff. His respected father died at Ventnor 23 years ago, when Mr. Buckell acquired the practice, which he had conducted since with evident satisfaction to his clients. Mr. A. W. Drew joined him about 15 years ago, and will in future carry on the business. Mr. Buckell was a Freemason, being Past Master of the Albany Lodge at Newport, and he was also a member of the Yarboro' Lodge at Ventnor. A few years ago he was elected a member of the Ventnor District Council, and but for the unsatisfactory state of his health he would, we believe, have more closely associated himself with many other branches of public work in Ventnor. He had a very large practice as family solicitor at Ventnor and was universally esteemed and respected. The very greatest sympathy is felt for the widow and her young family in their sorrow.

The funeral is fixed to take place on Tuesday next at Newport Cemetery, where the remains will be laid to rest beside those of his late father. The service at St. Thomas's Church will be at 3.30.
