Death of Mr. Edwin Carwardine.—Much sympathy is felt for Mrs. Carwardine, of the Lamb Inn, in the death, which occurred with unexpected suddenness on Sunday, at the Hampshire County Hospital, Winchester, form heart failure, of her husband, Mr. Edwin Carwardine, for some nine years the wellknown landlord of the familiar hostelry named above. Deceased, who had attested, left home during the previous week to join the Colours at Winchester. After arriving there he had a seizure, which necessitated his removal to the hospital, where he was visited by his wife and mother during the week-end. He then seemed better, but subsequently he suddenly collapsed through heart failure. The news of his death came as a shock to his many friends, who deeply sympathize with the young widow and his two boys in their bereavement. Deceased was a keen sportsman and a member of the Conservative Club. The funeral took place on Thursday, the first part of the service being at the Parish-church and the interment at Newport Cemetery, the Rev. J. L. Spratt officiating. The chief mourners were Messrs. Urban Gravett and Walter Holloway (brothers in-law), and the mourners also included officers and other representatives of the I. W. Licensed Victuallers' Society, of which deceased was a member, these being Messrs. H. Moger (president), A. Perry (vice-president), C. W. Orman (ex-president), D. C. McDonald, T. Hyde, N. H. T. Mursell, T. C. Phelps, H. Dakin, F. Payne, and J. A. McQueen (hon. secretary), and Capt. J. Burridge. The floral tributes included a cross of lilies from his sorrowing widow; half crescent from his sons Teddy and Tommy; and other souvenirs from his mother; Walt and Laurie (brother-in-law and sister-in-law); Urb and Nellie (brother-in-law and sister-in-law); I.W. Licensed Victuallers Society; old pals—the Two Macs'; Mr. Burt and Mrs. Leigh; Sapper and Mrs. Smith; Mr. and Mrs. Mursell; Mr. and Mrs. Booth and family; Mrs. Holloway (mother-in-law); and Aunt Thirza.
