DEATH OF MR. Wm. FISHER. - We regret to announce the death on Thursday, at Madeira House, Strand, Ryde, of Mr. Wm. Fisher, of the firm of Messrs. Fisk and Fisher, aged 39. The deceased went to Ryde for a change and rest, and whilst there caught a chill, which developed into pneumonia, and he passed away after a fortnight's illness. The late Mr. Fisher, whose home was at Uxbridge, came to the Island nearly 10 years ago as manager for Mr. John W. Fisk, merchant, &c., of St. Cross Mill, and eventually became a partner in the firm. He was very popular in agricultural, trade and sporting circles, and his untimely death is deplored by a large circle of friends, who deeply sympathise with his widow and two young sons in the irreparable bereavement. The funeral will take place on Monday next at Newport Cemetery, the first part of the service being at the Parish-church at 3 p.m.
