## DEATH OF MR. THOMAS PARKER MEW.

With great regret we have to record the death of Mr. Thomas Parker Mew, which took place at Lymington on Thursday night, his years exceeding, we believe, three score and ten. The eminent service which, years ago, Mr. T. P. Mew rendered to the borough of Newport as a member of the Corporation will be fresh in the recollection of our readers. Those services extended over a long period, during which he held on several occasions the office of Mayor, performing the duties of the position in the manner which reflected honour on the borough. In the course of Mr. Mew's municipal career important questions affecting the rights and privileges of the Corporation of Newport were frequently to the front, and those rights and privileges had no more champion than he. Unfailing urbanity and courtesy distinguished him in public life, while in private life there was about him a charm of geniality and kindliness which won for him friends everywhere. Though he had lived out of the Island in late years, his old friends here never forgot the pleasant asseverations of "Auld lang syne," and these same old friends, hearing now of the death of Thomas Parker Mew, will not fail to experience a pang of regret as they think of the "vanished hand" and the "voice that is still."
