Death of Mrs. Tilley.—We greatly regret to announce the death, after a short illness, on Wednesday at an advanced age of Mrs. Tilley at her residence, Highfield, Castle-road. The deceased, who was the widow of Mr. B. W. Tilley and only child of the late Mr. Thomas Self, was a member of a well-known and greatly respected Island family. She was a lady of many and varied activities and prominently identified herself with and rendered valuable help to a great number of organizations. She was a very active member and worker in connection with the Parish Church for many years, and a district visitor. Mrs. Tilley was also a member of the County Insurance Committee from its inception until the end of last year, and of the County Public Health, Housing, and Maternity and Child Welfare Committees for 10 or 12 years. As an ardent Liberal the deceased was to the fore in her work for that cause, and had filled the offices of vice-president of the I.W. Liberal Association, vice-president of the Newport Young Liberals League, and treasurer of the Newport Women's Liberal Association. Other activities of this remarkably public-spirited and hard-working lady were as secretary of the Newport Infant Welfare Centre, a member of the West Wight Preventive and Rescue Society, one of the oldest collectors of the Newport Benevolent Society, local secretary of the I.W. Needle-work Guild, a member of the women's branch of the British Legion, some-time member of the I.W. Sanatorium Sub-Committee, honorary member from its commencement of the Lady Simeon Court of Foresters, and an associate member of the Girl Guides Association. She leaves two daughters, one being the wife of Mr. Leonard Jordan, J.P. Her three sons pre-deceased her. The funeral will take place today (Saturday), the first part of the service being held in the Parish Church.

The Funeral—of Mrs. Tilley, whose death was recorded last week, took place on Saturday, the large congregation at the Parish Church testifying to the respect and esteem in which the deceased was held. The service was conducted by the Vicar (the Rev. Canon C. H. Thompson, M.A.) and the Rev. Dr. S. W. Sutton.
