#### NEWPORT

Death of Mr. Henry Waterworth, J.P.—An old and universally-esteemed inhabitant is gone from amongst us in the person of Mr. Henry Waterworth, F.R.C.S., J.P., who passed away on Thursday last, at the ripe age of 78. Though the profession of which he was an honoured member ever claimed his first attendance, the deceased was always ready, when in health, to devote a portion of his time to the service of the town. In 1852 he entered the Council as a representative of the North Ward, and in 1859 he was appointed an alderman of the borough, which latter office he continued to hold until 1872, when he resigned his aldermanic gown, and the late Mr. Henry Mew was elected in his place. He was on several occasions offered the Mayoralty, but a naturally-retiring nature led him to decline an honour which he was in every way qualified to sustain. In 1875 he was appointed on the Commission of the Peace for the borough. For many years he held a commission, as surgeon, in the Isle of Wight Artillery Militia, and at the time of his retirement the warmest expression was given to the esteem in which he was held by his brother officers and by the whole regiment. The devoted partner of his long life survives, and she and the other members of the bereaved family may find some solace in the assurance that they have the deepest sympathy of this community, and in the knowledge that the lamented deceased so lived as to leave behind him a name and a memory which will always be held in honour in Newport. The funeral of the late Mr. Waterworth will take place on Monday morning next, and the Mayor has invited the magistrates, members, and officers of the Corporation, with any other persons desirous of showing their respect to the memory of the deceased, to join him in attending the obsequies.

**The Late Mr. Henry Waterworth, J.P.**—In the course of his sermon at St. Thomas's Church last Sunday evening, the vicar (the Rev. Canon Haigh) referred to the late Mr. Henry Waterworth, remarking that by his skill in his profession—one of the noblest professions—by the conscientious way in which he discharged his duties of a Justice of the Peace, by the interest which he had shown in, and the time he had given to, the administration of the public charities of this town, of which he was a trustee, he won the respect of all. And though for five years he had been taken away almost entirely from public and professional life—though he had led during those five years the life of a secluded invalid—his previous long life in this town was not forgotten, and when the Mayor and Corporation, the magistrates of the borough, the members of his own profession, and the officers and non-commissioned officers of the staff of the Militia, with which he was connected long years before, came to that church and to the cemetery to attend his funeral, they came to testify publicly the great respect in which Englishmen held a man who had conscientiously tried to discharge the duties of his life.
