SAD DEATH OF A BOROUGH OFFICIAL

Much sympathy will be extended to Mr. and Mrs. A.E. Cooper, of 14 Barton-road, in the great loss they have suffered by the pathetically sad death of their only son, Mr. Arthur James Cooper, aged 28 years, which occurred at the County Hospital on Wednesday after only 10 days' illness. The deceased, who was an able and much esteemed member of the borough accountant's staff as accounts clerk, had not altogether recovered from the effects of a chill when, unfortunately, a more serious development necessitated his removal to the County Hospital. He received the skilled attention of three doctors in addition to the hospital staff, but it was unavailing and death came peacefully on Wednesday night from the effects of a rare disease known as Landry's acute ascending paralysis. The deceased, who was a scholar at the Nodehill School during the headmastership of the Mayor (Mr. J. L. Mitchell), was one of the most promising pupils, and in his subsequent career his worship has always evinced the keenest interest. On leaving school he was employed by the late Mr. Harry Shepard, J.P., C.C., in a clerical capacity, and entered the service of the Corporation in June 1923. His work for that authority was unostentatiously done, but the interest and ability he displayed were above the average and were invariably favourably commented on by auditors and others who had occasion to inspect his books. Keenly interested in sport and all youthful pursuits, he was for some time a member of the 1st Newport (Old Guard) Troop of Boy Scouts and retained his interest in that movement. Cricket and football also claimed his attention, and for several seasons he played for Porchfield C.C. His untimely end is the more to be deplored from the fact that he contemplated matrimony, and sincerest sympathy will be felt for Miss Doris Russell, of Gunville-road, Carisbrooke, his fiancée, in her irreparable loss. The funeral service will be held at St. Paul's Church, Barton, on Monday, at 2.30, the interment following at St Paul's Cemetery.

FUNERAL OF MR. A. J COOPER

The funeral of Mr. Arthur J. Cooper, of 14 Barton-road, whose sad death was reported last week, took place on Monday, the first part of the service being held in St. Paul's Church. The Rev. G.C. Seymour (rector of Wootton) officiated in the unavoidable absence owing to indisposition of the Vicar (the Rev. M. Atkinson). Mr. L.E. Dore was at the organ and played "O rest in the Lord" and other suitable selections before the service, and Chopin's Funeral March as the cortege left the church. The hymns sung were "On the resurrection morning" and "Peace, perfect peace," and the 23rd Psalm was chanted. The family mourners were Mr. A.E. Cooper (father), Mrs. W. Moore (sister), Mr. F. Coleman (grandfather), Mr. and Mrs. A. Mearman (uncle and aunt), Mr. J. Cooper and Mrs. G. Coleman (uncles), Mesdames Warne and Bradley (aunts), Messrs. R. and W. Cooper and Mrs. H. Gray (cousins), Messrs. W. Moore and J. King (brothers-in-law), and Miss D. and Mrs. Russell. The deceased's mother was unable to be present.
