FORESTER'S FUNERAL. — A largely-attended Forester's funeral took place at St. Paul's, Barton, Cemetery on Sunday-afternoon, at the burial of the late Mr. Alfred Edward Rayner, aged 40, of Beech-road, Bartons-village, whose death took place on the previous Wednesday from consumption. In addition to the personal mourners those present included Messrs. Frank, Ernest, and Percy Croucher and the office staff and a large number of other employees of Messrs. Crouchers, Ltd., of who deceased had been a respected and faithful employee for over 20 years. Flags on vessels at the quay were at half mast. There were also present nearly 100 members of the Court Island Foresters, of which deceased was a member, including Bros. C. Eldridge, C.R., F. Spanner (secretary), G. Jones, P.C.R., H. Way, P.C.R., R. Mytton, P.C.R., and W.H. Dyer, P.C.R. (secretary of the sick members' fund). At the Court-room, before proceeding to the funeral, a collection was made on behalf of the widow and large family. Fellow employees of the deceased acted as bearers. The Rev. J. Ruddle (pastor of the Unitarian Christian Chuch) officiated, and members of that Church were among the mourners. There were a number of floral tributes.
